# What is final research data?



- A collection of final version of data that exists during the last stage in the data lifecycle in which all re-workings and manipulations of the data by the researcher have ceased. (Source: [NTU Research Data Policy Section 4.](#))
- It is the final version of raw data used to establish and validate research findings—the underlying raw data behind the tables/charts/figures in your published papers.

Example: tabular files (csv, excel files)

# What not to share?

1. **Sensitive data**, including data that
  - contains human subject identifiable information
  - is of commercial-in-confidence nature
  - is national security related
  - has patent/commercialization potential



*Other types of sensitive data:* data can be used to identify species, object, or location that introduces harm or unwanted attention. E.g., ecological data that may place vulnerable species at risks. (Source: Safely sharing sensitive data, ANDS)

# What not to share?

2. **Proprietary secondary data** that you purchased or obtained from external sources (e.g., databases or collaborators) that come with **terms of use** which would not allow you to share/re-distribute the data.



Secondary data is the data that has been collected by others, for another purpose, but has some relevance to your research needs.

**Can I assign other project member(s) to upload data files/create dataset records in my sub-dataverses in DR-NTU (Data) or NIE Data Repository?**

# Can I assign other project member(s) to upload data files/create dataset records in my sub-dataverse(s)?



Yes, there are different levels of permissions which you can assign to other project team member(s) for your sub-dataverse(s) in DR-NTU(Data) or NIE Data Repository.

Before you can assign permissions to your project team member(s), they would have to do a first-time login to DR-NTU (Data) or NIE Data Repository.

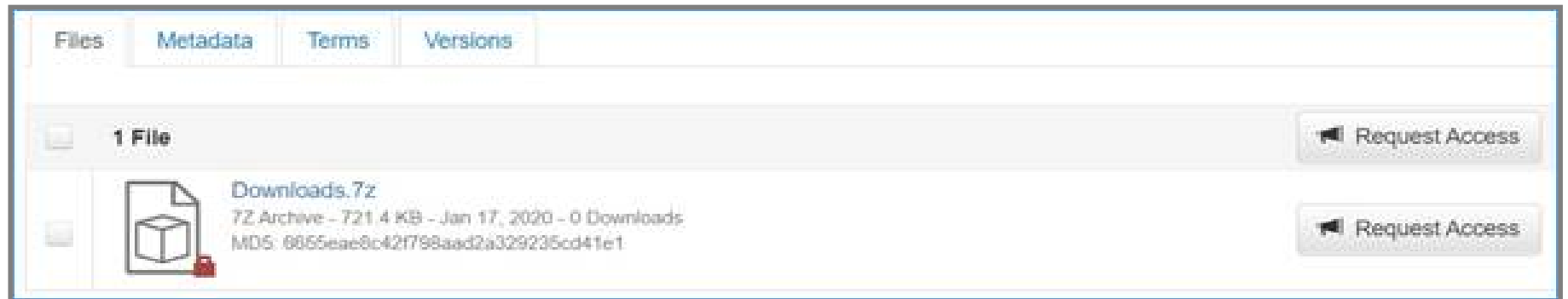
**Can I restrict access to my data?**

# Can I restrict access to my data?

Yes, you can restrict access to some of the files in your dataset record in DR-NTU (Data) or NIE Data Repository.

Will I be able to share my **unpublished** dataset with those who do not have a DR-NTU (Data) or NIE Data Repository account?

# Will I be able to share my **unpublished** dataset with those who do not have a DR-NTU (Data) or NIE Data Repository account?



Yes, you can do so by generating a private URL via your dataset record in DR-NTU (Data) or NIE Data Repository.

Also useful when your paper reviewers request to view unpublished datasets.

You can disable it anytime too.

**Do I need to deposit my data in DR-NTU (Data) or NIE Data Repository if I have already deposited my data in external data repositories?**

## 7. Do I need to deposit my data in DR-NTU (Data) or NIE Data Repository if I have already deposited my data in other data repositories?

Depositing in multiple repositories might create multiple Persistent Identifiers (e.g. multiple DOIs), hence we discourage depositing the same dataset to multiple repositories.

Exceptions can be made for any remaining research data which was not shared in other repositories.

# When do I need to deposit my dataset in DR-NTU (Data) / NIE Data Repository?



	NTU Projects	NIE Projects
<b>When</b>	Deposit shall be made no later than publication or 12 months after the project end date whichever is earlier.	No later than the publication of the article

*Note:* Deposit ≠ Publish. You can deposit first, and publish later when you are ready.

**How do I include a link to my data for my journal paper?**

# How do I include a link to my data for my journal paper?

Through a **Data Availability Statement** that describes where the underlying data for a research paper can be accessed.

- give it to your journal as soon as your paper has been accepted, or earlier.



*Example:* "The data that support the findings of this study are openly available in [repository name] at [http://doi.org/\[doi\]](http://doi.org/[doi])"

Note: You can give the DOI to your journal even when your dataset is still unpublished. The DOI will not change when you publish the dataset later. Just remember to publish your dataset no later than the publication date of your paper.
